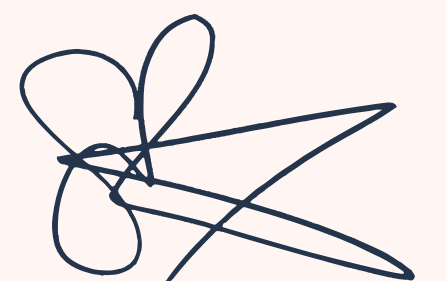

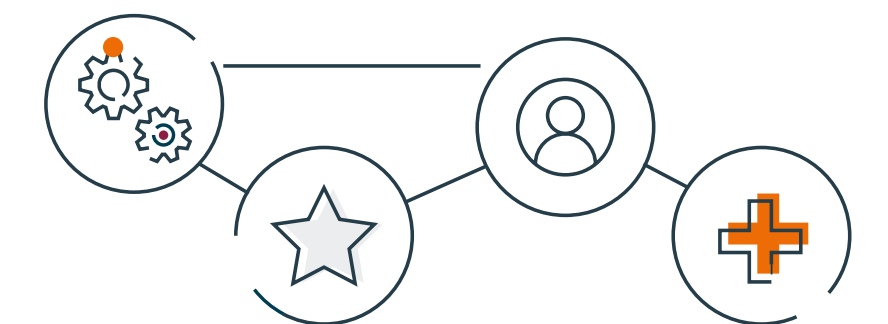

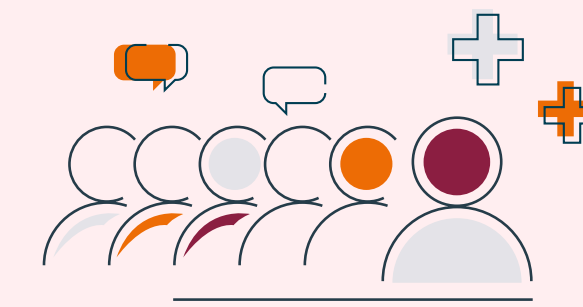
We donate our time and talents to disadvantaged groups and small frontline charities that most need the skills our people bring to the table.

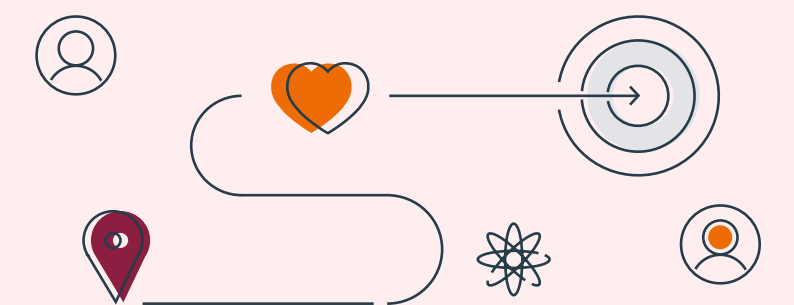
Above all, we're helping our clients to achieve their own responsible business and ESG goals – integrating purpose and long-term sustainable thinking into the way we work with them.

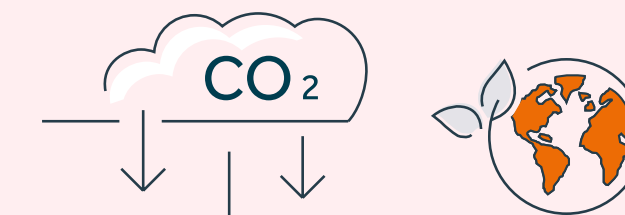

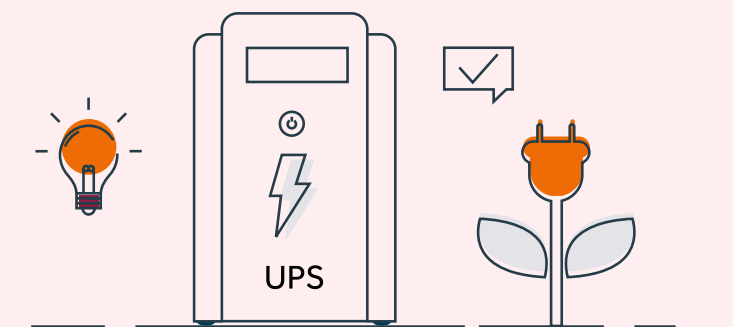
